Reunion News

Charleston, W VA 2009

Twenty five shipmates fifteen accompanied by their wives enjoyed four days or more in Charlotte. With the car show on Saturday and Sunday many of us arrived Saturday. There were over 800 antique and other cars to see, my wife was impressed by the 1955, 56, and 57 T Birds. Others had their favorites, too numerous to mention. All were impressive, some in like new condition, others rebuilt with new paint, upholstery and modified engines. It took just about two days to see most and probably many were missed.

Registration for the reunion started at 3:00pm Sunday. There were goodie bags, beverages and finger food for starters even though we were heading out to the "Fifth Quarter" for dinner at 6:00 pm. Opening ceremonies included presentation of the colors and a welcome by the Mayor of Charlotte, Danny Jones. Francis and Howard Justice gave us a brief of the agenda for Monday prior to our returning to the Hospitality Room to chat and relax.

Monday found us getting on a bus at 0800 for a trip to Beckley, WVA and a tour of the Beckley Coal Mine. If you had never been in a coal mine working conditions are difficult to realize. In their day, there was barely room to sit up let alone stand. Pay in the early 1900's was twenty-five cents a ton with about four tons a day mined by one person. We were fortunate to be able to ride in a tram to see what was once the working area opened to accommodate visitors. There was about a thirty minute period that a retired miner was able to show us equipment used in earlier days of mining. The equipment included the cages canaries were carried in, carbon lights, more modern battery operated lights, meal and water buckets. We saw methods of early excavation by dynamite, and newer methods by equipment similar to a mechanized chain saw that made horizontal cuts into the coal vein. The coal veins appeared to be only one and a half to two feet high. After leaving the mine we were taken to Tamarack shopping center where we also had time for lunch. Tamarack is an upscale shopping center where only items made in West Virginia are sold.

Tuesday morning was open and leisure time, we boarded the bus at 12:30 for the trip to the Blenko Glass Factory. There were several demonstrations of glass blowing and shaping during our time there. Many of the groups were seen in the showroom buying the wares. After we left the factory we were bussed to the Gym at the Church Howard and Francis attend. Their family prepared an excellent wholesome West Virginia spread for us. There was no "Roadkill", but a delicious meal. Thank you all for the hospitality. We were entertained by a local Bluegrass group the Kidd Brothers. I don't remember if they explained why "Brothers", to my knowledge they were not related. Regardless, they put on an outstanding show for us. A request was made for "Moose" to join the band for a couple songs, which he did to the delight of all. There were interruptions between some band selections while Howard and Francis gave out very unusual West Virginia door prizes "donated by local entrepreneurs" Needless to say a good time was had by all.

All good times must come to an end but prior to leaving attendee photos that had been taken the previous day by the Justice's Son were passed out. After viewing them some of the attendees almost passed out. The pictures are classic, I will not show any in the newsletter though. Take my word they are truly West Virginia Classic. Agent Orange Updates VA Announces Progress on Agent Orange Claims

The Department of Veterans Affairs (VA) Secretary Eric Shinseki announced a decision to establish a presumptive service-connection for Vietnam veterans who have B cell leukemia, Parkinson's disease or ischemic heart disease. These diseases are all related to exposure to Agent Orange, a herbicide used in Vietnam. Secretary Shinseki's decision was based upon the recently released Institute of Medicine (IOM) report that was mentioned in the July 31, 2009, edition of Newsbytes. FRA is advocating for a broader Agent Orange service-connection and this announcement is a major step in the right direction. Many Navy veterans who served off the coast of Vietnam, so-called "blue water" veterans, have health problems frequently associated with herbicide exposure, but have endured lengthy legal struggles to prove these problems are service-related. The Association has repeatedly pushed for a legislative remedy (H.R. 2254) and has referenced this issue as a priority for 2009 during the military and veterans' service organization meetings with the House and Senate VA committees.
